The website, PainCommunity.org saw an increase in the number of visitors to the website over the previous year. The number of people interacting in the chatrooms and discussion forums also increased throughout the year. The number of subscribers to the quarterly email newsletter increased over the previous year. Development of all website contents and all of the activities related to moderating the interactive portions of the website were undertaken by volunteers. Volunteers create content, format and send out the newsletter to individual subscribers who have provided their email address to the organization. Volunteers represent the organization as a collaborator for public awareness and education. Expenses related to this activity in 2016 included website hosting and internet software services. A section of the website was added to accommodate meta cancer pain patients. Live hosted telephone support group conference calls were added in 2016.
