The organization was begun in 2005 to encourage the involvement of citizens in advocacy activities that would create an infrastructure to support the mitigation of insufficient treatment of women with pain. In 2011, the volunteer board members acknowledged that other larger organizations have been more impactful in achieving this mission and considered terminating the organization. A review of published materials on the subject of women with pain was begun in 2011 by a volunteer. The organization is now exploring other options for activities consistent with the mission of increasing awareness of treatment options for people living with pain. The organization has no assets and maintains a post office box to accommodate communication with the State of California and with the IRS. The cost of the post office box rental was \$116. The organization was charged \$165 in bank service fees depleting the balance in the account to \$33.46 as of 31 December 2011.
