The website www.PainCommunity.org, launched in 2013, saw a 47% increase in the number of visits to the site. 64% of the visitors to the website were new visitors. The number of people interacting in the chatrooms and discussion forums increased by 75%. All of these activities are undertaken by volunteers. Expenses related to this activity in 2014 were limited to computer, internet and website hosting. Revenue was received from some participants in the discussion forums and online chat sessions.

Increased activity on the organization's FaceBook page and added a Twitter account to further access social media. Volunteers set up the accounts and continue to monitor activity on the page.
