The website, PainCommunity.org, saw a 62% increase in the number of visitors to the website over the previous year. The number of people interacting in the chatrooms and discussion forums also increased throughout the year. The number of subscribers to the quarterly email newsletter by 33% compared to the previous year. Development of all website content and all of the activities related to moderating the interactive portions of the website were undertaken by volunteers. Volunteers create content, format and send out the newsletter to individual subscribers who have provided their email address to the organization. Expenses related to this activity in 2015 included website hosting and internet software services.

The organization continued it's public awareness and education efforts by sponsoring a radio program that addresses pain conditions and pain treatments. The awareness and education effort includes generating pain topic resource lists, pain related articles and establishing reciprocal resource reference relationships with other pain support organizations.
